**"To call this work 'unnecessary' is to ignore the documented reality that I was a witness being erased by two multi-million dollar interests. When the institutions meant to protect me failed, Brightmare became my only structure of defense. It wasn't a choice made for 'art' or 'publicity'; it was a mitigation strategy made for survival."**

**Note on Guerrilla Narrative Warfare:** The Brightmare exhibition was a strategic exercise in Guerrilla Narrative Warfare. This project serves as a Contemporaneous Factual Record of whistleblower reprisal. When powerful public figures attempted to rewrite my history including false claims regarding the parenting of my children and the discrediting of my testimony I recognized that being pathologized as "unstable" was an inevitable tactic used by these entities to neutralize a witness.

**"I did not perform madness; I performed that inevitability."**

**Regarding Protection & Erasure:** This work was necessitated by a total absence of institutional protection. Because I possessed knowledge regarding the forgery of government documents (the FBI letter), I was viewed as a liability by two opposing high-profile legal interests:

**The Documentary (Phoenix Rising):** Erased my existence to protect the performative value and commercial viability of their narrative., performative trauma culture.

**The Defense (Marilyn Manson):** Attempted to pathologize my identity through parasocial narratives to control or devalue my testimony., to reframe professional whistleblowing action re: documentation forgery into categorized 'delusional fan' action rather than materiel witness.

**The Source of the Problem:** Both groups used a story made up by a person who is known for lying. This person was willing to fake FBI documents just to help a Hollywood documentary attack a celebrity. Because I had no one to protect me, what they did to me was even worse: they stole \$150,000, stole my identity, and spread lies saying I was disabled, in jail, or dead all just to keep me from speaking the truth in court.

**Legal Conclusion:** My participation in Brightmare was a Mitigation Strategy. By "collecting" the narrative abuse as it happened, I preserved the truth of my experience. This archive is the primary evidence of that collection. Any attempt to characterize this structured documentation as "instability" is a documented act of further reprisal and defamation.
