**Public Endangerment:** The use of "swatting" tactics against public figures to manufacture crises.,

**Identity & Death Fraud:** The dissemination of false reports regarding my "death" or "incapacity" to solicit money from family members and bypass my parental and business authority.,

**Medical Gaslighting:** The characterization of my lyrics and creative IP as "threats" to provide a legal veneer for silencing me.,

**LEGAL STANDING:** Under the Public Interest Disclosure Act 2013 (Cth), causing detriment to a whistleblower is a criminal offense.
